## Introduction

#### **About the festival**

Africa in Motion (AiM) is an annual African film festival taking place in Scotland, that delivers film screenings and complementary events. Now in its sixteenth year, AiM brings the best of African cinema to Scotland—making it possible for Scottish audiences to engage with African stories and industry professionals from the continent. AiM has established itself as a major annual event within the Scottish cultural calendar, whilst also maintaining an international profile as one of the leading African film platforms. The festival caters to a varied and diverse audience from all over Scotland, the UK and further afield.

#### **Our Vision**

A world where African and Black diaspora artists are supported wholly with all the resources they need to experiment and forge their visionary work. We believe that their stories matter and have the power to transform the world.

#### **Our Mission**

To empower African and Black artists from the diaspora to take control of their own narrative, celebrate their heritage, and showcase their stories to global audiences. We practice this by curating the very best of African cinema, exploring the depth, complexity and vibrancy of the continent, the people who live there, and the stories it holds, past, present and future.

#### How we are Funded

AiM is mainly supported by Creative Scotland through the Screen Scotland fund to advocate for underrepresented filmmakers, exhibit African cinema and present supporting activities such as masterclasses, workshops and various audience engagement pursuits. Africa in Motion is a member of Film Hub Scotland — one of the regional hubs in the BFI's FAN (Film Audience Network), charged with the provision of programming, advisory and information services for the sector.

Over the last 16 years we have also received financial support from the British Council, Impact Funding Partners and various Scottish academic institutions, amongst others. Since 2006 we have:

- Screened 1,000 + African films.
- Produced the <u>Africa's Lost Classics</u> touring project, which aimed to safeguard the history of Africa's 'lost' classics - films that have been forgotten, neglected or lost. The project is rooted in the belief that cinema contributes significantly to the cultural history of the continent.
- Produced the <u>African Film Database</u>, a platform with over 2,000 films, providing anyone with an interest in African cinema with the ability to research titles.

## **Our Board**

Africa in Motion is rooted in Scotland, with an office in Glasgow. Board meetings have previously taken place in Edinburgh, and we expect our Trustees to have an understanding of the festival's strong commitment to Scotland. However, you can be **based anywhere in the UK**, and it is highly likely we will continue meeting online to be as accessible as possible. This is a **voluntary**, **unpaid role**, although we will reimburse any expenses you incur in your duties as a member of the Board. We currently have five Board members:

#### Cllr Graham Campbell (Chair)

Glasgow City Councillor and Co-Convener of African Caribbean Cultures, Glasgow. He is a musician and cultural producer with three decades of anti-racism campaigning and community activism. Joining AIM Board in 2012, he was elected Chair in 2018. In May 2017, he was elected as Glasgow's first African Caribbean Councillor. In May 2022 he was appointed Chair Education Skills & Early Years City Policy Committee. He was instrumental in Glasgow City Council holding its first-ever official Black History Month event in 2017. He chairs the Council's slavery legacy working group and is Project Leader of 'Flag Up Scotland Jamaica' a twinning & reparative justice project.

#### Dr Stefanie Van de Peer (Vice Chair)

Reader in Film Studies at Queen Margaret University. Stefanie's areas of study have been focused on women making documentaries in North Africa. She is a film historian interested in non-mainstream filmmaking such as activist non-fiction and animation, and the manner in which these art forms have been perceived and received on international festival networks.

#### Olumide Fadeyibi

Filmmaker and director of film and video production company Turn Flicks. His mission is to inspire generations to come and to make this world a better place for all.

#### Joanna Keating

Head of International Development Team at Scottish Government. She works with the Minister for Culture, Europe & International Development; responsible for policy direction on their International Development Fund and the Humanitarian Emergency Fund.

#### **Dr Peter West OBE**

Malawi's Honorary Consul in Scotland. He established and led the Strathclyde University Malawi Millennium Project, and subsequently served as chair of the Scotland Malawi Partnership until his appointment in 2010 as Scotlish Honorary Consul of the Republic of Malawi. He is a Deputy Lieutenant of the City of Glasgow.

# **Trustee information**

#### What we're looking for

You don't need to have an arts background or a university degree to be a Trustee, or to have reached any particular stage in your career. We want to hear from people who bring something new, will challenge us, and who want to help us grow. We invite applications from people who are passionate about Africa in Motion's vision, the arts/culutral sector, and those with lived\* and/or professional experience in these key areas:

- Law
- HR and policymaking
- Accounting/Financial governance
- Professional filmmaking/acting/media industry experience
- Fundraising and Sponsorship experience
- PR / Marketing and digital production
- Community building
- Strategic planning and business management

If you don't meet any of the above, we still encourage you to submit your interest, but we may prioritise other applicants to ensure a well-rounded, representative board.

Please note that the role is unpaid, and the deadline for sending us your expression of interest is 11:59 PM, Sunday 23rd October, 2022.

\*By this we mean: "Personal knowledge about the world gained through direct, first-hand involvement in everyday events rather than through representations constructed by other people." Some may consider it more in terms of personal identity or culture. You do not have to disclose which, if any, lived experiences you identify with as part of the application process.

Some examples include: being chronically ill, d/Deaf, Black British, Black African, desi, disabled, LGBTQ+, non-binary, refugee or Asylum Seeker, visually impaired, working class, mixed heritage and so on.

# **The Opportunity**

### Responsibilities:

All charity trustees have legal duties and responsibilities under the 2005 Act.

These include:

- Reading organisation reports and minutes, and come to the meetings prepared to ask questions, discuss, and act as a critical friend to ensure that the charity is being run well.
   You will work closely with the Festival Director taking a strategic overview of the organisation's planning.
- Demonstrate commitment to our policies including our equalities, diversity and inclusion policies, and a commitment to the values and mission of the festival as a newly Black-led organisation.
- Protect and manage the assets of the organisation, ensuring the financial stability of the charity and the proper investment of its funds.

We will work with you to make sure that there is a detailed induction, and we will discuss what support you might want in your first months, such as a buddy system, to make sure that you have everything you need to play a fully effective role on the Board.

**Application** Process

To start the conversation, we request an expression of interest. Email a one page cover letter or a short video of no longer than 2 minutes (preferred format MP4). Please tell us:

- Why you would like to join the Board.
- What you think you would bring to the organisation and how your skills could support the Board and team in achieving its vision.
- A bit about yourself, the work you do, and your previous experience.

Deadline: 11:59 PM, Sunday 23rd October 2022. To apply, please submit your letter or video here.

We plan to interview **W/C 25-30 November**; when you contact us, please let us know if you are not free on these dates. We want everyone who believes they can contribute to AiM's Board of Trustees to feel welcome to apply. It is our responsibility to make the application process accessible, and to give you the information you need to decide whether you might be suitable.
